## **RESOLUTION NO. 170 series of 2020**

**A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL, REPRESENTED BY THE MUNICIPAL MAYOR HON. GEORGE RICARDO R. GACULA II AND PALMERA HILLS II TRICYCLE OPERATOR DRIVERS ASSOCIATION (PHAI II TODA) REPRESENTED BY ITS PRESIDENT MR. RUBEN V. VILLEZA FOR THE USE OF A PARCEL OF LOT, WITH TCT. NO. 649274 UNDER THE NAME OF THE MUNICIPALITY OF TAYTAY AS PALMERA II TODA OFFICE**

WHEREAS, the Palmira Hills II TODA, thru its President had requested the Hon. Mayor George Ricardo R. Gacula to give authority to their association to act as overseer to a parcel of lot covered by Transfer Certificate Title No. 649274 with existing structure under the name of the Municipal Government of Taytay, Rizal, located at Palmira II Subdivision, Taytay, Rizal;

WHEREAS, the Sangguniang Bayan of Taytay, Rizal passed Resolution No. 408 series of 2019 last June 13, 2019, authorizing the Mayor to enter into Memorandum of Agreement (MOA) with Palmera II TODA for the use of the parcel of lot under the name of the Municipality of Taytay as Palmera Hills II TODA Office;

WHEREAS, the MOA between the Municipality of Taytay and Palmera Hills II TODA was signed last February 11, 2020;


