RESOLUTION NO. 172 series of 2020

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, TO GRANT CASH INCENTIVES TO ALL WITH HIGH AND HIGHEST HONOR GRADUATING STUDENTS OF PUBLIC SCHOOLS IN ELEMENTARY AND HIGH SCHOOL AND THE UNIVERSITY OF RIZAL SYSTEM, IN THE MUNICIPALITY OF TAYTAY, RIZAL, AND APPROPRIATING FUNDS THEREOF

WHEREAS, Article XIV Section 1 of the Philippine Constitution mandates the promotion and protection of the rights of all citizens to quality education at all levels and the taking of appropriate steps to make education accessible to all;

WHEREAS, the constitution further mandates the establishment and maintenance of a system of scholarship grants, student loan programs, subsidies and other incentives which shall be available to deserving students, especially to the underprivileged [Art. XIV. Section 2(3)];



WHEREAS, it should be the initiative of the Municipality of Taytay to give credit to all students who exert their best effort to achieve their goals in finishing their education in order to have a better future;

WHEREAS, granting cash incentives to graduating students who achieve the high and highest honor will encourage more learners to strive hard and fulfill their dreams and will also help pave way in raising further the quality of education;

WHEREAS, the cash incentives to be given to all high and highest honor students of graduating class in every Public School and the University of Rizal System in this Municipality shall be upon the discretion of our Local Chief Executive, Hon. George Ricardo R. Gacula II, subject to the rules and conditions of government regulatory bodies and Commission on Audit;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, TO GRANT CASH INCENTIVES TO ALL WITH HIGH AND HIGHEST HONOR GRADUATING STUDENTS OF PUBLIC SCHOOLS IN ELEMENTARY AND HIGH SCHOOL AND THE UNIVERSITY OF RIZAL SYSTEM, IN THE MUNICIPALITY OF TAYTAY, RIZAL, AND APPROPRIATING FUNDS THEREOF.
