RESOLUTION NO. 173 series of 2020

A RESOLUTION REQUESTING THE SUPPORT AND ENDORSEMENT OF GSIS IN ALLOWING VOLUNTARY CONTRIBUTION OF ELECTED OFFICIALS WHO HAVE SERVED ATLEAST NINE YEARS IN THE LOCAL GOVERNMENT UNIT

WHEREAS, the Philippine Councilor's League, an association of all elected councilors in the country with more or less 17,000 members have adopted Resolution last January 20, 2020 through its National Executive Officers and National Board calling for the support and endorsement of GSIS to allow voluntary contribution of elected officials who have completed nine years of service;

WHEREAS, Section 11 to 13 of RA 8291 otherwise known as the GSIS Act of 1997 clearly states that benefits shall be payable to the members who have rendered at least fifteen years of service;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of the Philippines defines the term of elective local officials except the barangay officials to three (3) years and no such official shall serve for more than three (3) consecutive terms limiting to a maximum duration of nine years which includes councilors in the country, therefore disqualifies them to GSIS benefits that shall be payable only to the members who have rendered at least fifteen (15) years of service;

WHEREAS, the August body of the Municipality of Taytay, Rizal is one in opinion that by allowing elected officials to have served for atleast nine (9) years in service cumulatively the option to continue voluntary contribution to GSIS, they can ensure that their future needs during sickness, accidents or loss will be covered by an insurance benefits;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE SUPPORT AND ENDORSEMENT OF GSIS IN ALLOWING VOLUNTARY CONTRIBUTION OF ELECTED OFFICIALS WHO HAVE SERVED ATLEAST NINE YEARS IN THE LOCAL GOVERNMENT UNIT.

RESOLVED FURTHER, that copies be furnished and forwarded to all concerned for their information and appropriate action.
