THE EMERGING THREAT OF SPREAD OF COVID-19 IN THE

WHEREAS, there is an emerging threat of spread of COVID-19 in our country as stated in the Executive Order/Memorandum issued by the national government, duly signed by the President of the Republic of the Philippines Hon. Rodrigo Roa Duterte;



WHEREAS, in compliance to the mandate to prevent sustained community transmission, the Provincial Government of Rizal and the Municipality of Taytay had issued several Memoranda to minimize movement of constituents for possible spread of disease;

WHEREAS, the Municipality of Taytay as certified COVID-19 free as of 8:00 o'clock in the morning March 16, 2020 based on the report made by the Local Health Office Dr. Jeffrey Roxas during the Executive-Legislative Conference held at the Municipal Building, Taytay, Rizal on the updates and provision of measures to counteract the possible incoming threat to the community populace;

WHEREAS, stated below are the list of Executive Orders issued by the Local Chief Executive, this municipality:



## **Executive Order No. 117, S. 2020**

### **CREATING A PRICE MONITORING AND ANTI-HOARDING TASK FORCE IN THE MUNICIPALITY OF TAYTAY, RIZAL**

**WHEREAS**, President Rodrigo Roa Duterte issued Proclamation 922 on March 8, 2020 declaring a State of Public Health Emergency throughout the Philippines;

**WHEREAS**, the Department of Health has confirmed the Local Transmission of Corona Virus Disease (CoViD-19) in the Philippines;

**WHEREAS**, the municipality is mandated to exercise powers that are expressly granted or those necessary implied there from or power which are necessary appropriate of incidental for efficient and effective governance and which are essential for the promotion of the general welfare including the promotion of health and safety of each inhabitants to preserve and promote the general welfare;

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Disease issued Resolution No. 11 on March 12, 2020 which was approved by President Rodrigo Roa Duterte, after which, the Code Alert System for CoViD-19 public health event was raised to Code Red Sublevel Two (2);

**WHEREAS**, the full cooperation to the National Government and other agencies should be given by Local Government Units in order to prevent the spread of CoViD-19;

**WHEREAS**, it is imperative that during this situation, the Local Government Unit must see to it that no unscrupulous person should be allowed to take advantage of the said situation to the prejudice and detriment of the inhabitants of Taytay, Rizal;

**NOW, THEREFORE, I GEORGE RICARDO R. GACULA II**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby order as follows:

**Section 1.** There is hereby created a **Task Force on a Task Force on Price Monitoring and Anti-Hoarding in the Municipality of Taytay, Rizal** to be composed by the following departments:

- a. Department of Trade Industry of Taytay, Rizal;
- b. Business Permits and Licensing Office;
- c. Agriculture Office;
- d. Economic Enterprises Development Management Office;

e. Municipal Public Safety Office;

**Section 2. FUNCTIONS.** The Task Force on Price Monitoring and Anti-Hoarding in the Municipality of Taytay, Rizal shall have the following functions:

- a. Conduct daily monitoring of the prices of goods and commodities sold in every department stores, malls, markets, convenience stores and the like in order to determine if they comply with the suggested retail price that is provided or that may be provided on the said goods or commodities by lawful authorities;
- b. Act on reports or complaints or *motu proprio* conduct inspections on warehouses or other places that are reported, or it may determine, to be hoarding goods or commodities;
- c. File or recommend the filing of appropriate cases to persons or corporations who shall engage in over-pricing or hoarding of goods and commodities;
- d. Coordinate with every barangay which are hereby mandated to cooperate in the monitoring and prevention of unwarranted price increases on goods and commodities or hoarding; and
- e. Perform such other lawful functions as may be provided by the Local Chief Executive;

**Section 3. MEETING AND INSPECTIONS.** The Department Heads or Officers-in-Charge whose office is a member of the Task Force shall immediately convene in order to formulate their process and procedure in conducting inspections for this purpose;

**Section 4. REPORTS.** The Task Force shall make daily report to the Local Chief Executive on the state of prices of goods and commodities in Taytay, Rizal;

**Section 5. EFFECTIVITY.** This Executive Order shall take effect immediately.

## **Executive Order No. 18, S. 2020**

### **CREATING A TASK FORCE ON DISEASE CONTAINMENT AND CONTROL**

**WHEREAS**, President Rodrigo Roa Duterte issued Proclamation 922 on March 8, 2020 declaring a State of Public Health Emergency throughout the Philippines;

**WHEREAS**, the Department of Health has confirmed the Local Transmission of Corona Virus Disease (CoViD-19) in the Philippines;

**WHEREAS**, the municipality is mandated to exercise powers that are expressly granted or those necessary implied there from or power which are necessary appropriate of incidental for efficient and effective governance and which are essential for the promotion of the general welfare including the promotion of health and safety of each inhabitants to preserve and promote the general welfare;

**WHEREAS**, it is necessary to consolidate all the efforts and resources of the Local Government Unit in order to maximize the effectivity of its response to the present Corona Virus Disease (CoViD-19) and similar cases;

**NOW, THEREFORE, I GEORGE RICARDO R. GACULA II**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby order as follows:

**Section 1.** There is hereby created a Task Force on a **Task Force on Disease Containment and Control** to be composed by the following:

**Section 2. FUNCTIONS.** The Task Force shall coordinate the efforts of the various offices and agencies of the Municipality of Taytay, Rizal in setting up measures for the prevention and containment and control of the CoViD-19 and other diseases that can potentially spread throughout the community. Specifically it shall perform the following:

- a. Recommend actions that are aimed to prevent the CoViD-19 disease including the sanitation of places that it determines to be necessary;
- b. Formulate procedures in responding to reports of CoViD-19 infections including coordination with other government offices or agencies;
- c. Recommend the suspension of classes or any other activity that can potentially catalyze the spread of CoViD-19 or any other infectious disease;
- d. Conduct information dissemination involving preparedness and readiness in the advent on potential transmission of any disease within the community;
- e. Recommend the restriction of movement within the community if proper and necessary for this purpose;
- f. Require the performance of an action or mobilization of an office or agency of the Municipality of Taytay, Rizal for the purpose of accomplishing the prevention and control of the CoViD-19 or other disease;
- g. Perform any other actions necessary and proper and that are aimed in the prevention and control of the CoViD-19 and other infectious disease.

**Section 3. MEETING.** The Task Force shall meet upon the call of the Local Chief Executive or the Municipal Health Officer.

**Section 4. APPROPRIATION.** The expenses needed for the proper functioning of the Task Force shall be taken from the funds intended for this purpose;

**Section 5. EFFECTIVITY.** This Executive Order shall take effect immediately.

## Executive Order No. 119, S. 2020

### AN ORDER INTENSIFYING THE ENFORCEMENT OF PRECAUTIONARY MEASURES AGAINST THE COVID-19 DISEASE WITHIN THE MUNICIPALITY OF TAYTAY

**WHEREAS**, on December 31, 2019, a pneumonia of unknown cause detected in Wuhan in Hubei province, China was reported to the World Health Organization which was eventually named as COVID-19;

**WHEREAS**, on January 13, 2020, the first case of the COVID-19 outside China was confirmed in Thailand;

**WHEREAS**, on January 30, 2020, the World Health Organization declared the outbreak as a Public Health Emergency of International Concern after its escalation into an unprecedented outbreak in a global scale,

**WHEREAS**, on the same day (January 30, 2020, the first case of COVID-19 in the Philippines was confirmed by the Secretary of the Department of Health;

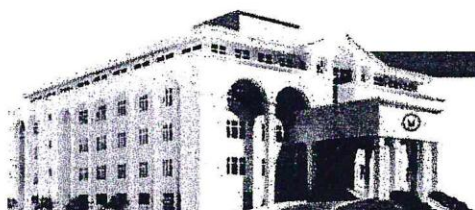
**WHEREAS**, on March 7, 2020, the Department of Health confirmed the first case of local transmission of COVID-19 in the country as the patient showed no recent travel history;

**WHEREAS**, on March 8, 2020, President Duterte issued Proclamation 922 declaring a State of Public Health Emergency in the advent of the threat of the COVID -19 virus which among others enjoined all government offices and LGUs to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

**WHEREAS**, on March 12, 2020, WHO characterized COVID-19 as pandemic;

**WHEREAS**, recently, a Memorandum from the Office of the Executive Secretary about Stringent Social Distancing Measures and Further Guidelines for the Management of the Corona Virus Disease 2019 (COVID-19) Situation;

**WHEREAS**, on March 14, 2020, there had been a total of 111 confirmed cases of COVID-19 in the country;

**WHEREAS**, the Department of Health is continuously asking the public to cooperate and help in the investigation and contact tracing activities of possible COVID-19 cases;

**WHEREAS**, in Proclamation No. 922, President Duterte called all citizens, residents, tourists, establishment owners to act within the bounds of law and to comply with the lawful directives and advisories to be issued by appropriate government agencies to prevent further transmission of the COVID-19 and ensure the safety and well-being of all;

**WHEREAS**, there is a need to intensify the precautionary measures that are already being undertaken by the Municipality of Taytay, Rizal and to involve everyone in the prevention, detection, mitigation, control and eventual eradication of the COVID-19 disease.

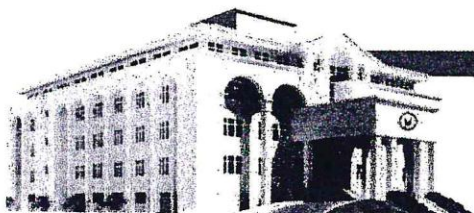
**NOW THEREFORE, I, GEORGE RICARDO R. GACULA II**, Municipal Mayor of Taytay, Rizal, by the powers vested in me by law, do hereby ORDER as follows:

**SECTION 1.** To mitigate and prevent the spread of the COVID-19 disease, all planned and spontaneous mass gatherings within the Municipality of Taytay are hereby prohibited. The term mass gathering shall be understood as a gathering where the number of people attending could strain the planning and response resources of the community hosting the event;

**SECTION 2.** Because of the proximity of the Municipality of Taytay, Rizal with the National Capital Region, and the possible influx of people as a result of the community quarantine in the NCR, all barangays are hereby directed to encourage them to report to their respective Rural Health Units (RHUs) for documentation and monitoring recommended by the DOH. For this purpose, the barangays may ask the assistance of the Homeowner's Associations within their respective jurisdictions;

**SECTION 3.** All government offices, schools, private sector offices and business establishments within the Municipality of Taytay, Rizal are hereby encouraged to practice social distancing measures and precautions recommended by the DOH and to temporarily postpone activities that may involve the congregation of students, employees, customers, buyers or clients.

**SECTION 4.** Establishments, businesses or those whose trade or profession, by their nature, cannot comply with social distancing, such as beauty parlors, saloons, barbershops, massage parlors and the like, or those whose services require close proximity or physical contact with their customers/clients shall be temporarily closed until the state of Public Health Emergency is lifted.

Furthermore, in accordance with the Memorandum of the Provincial Government of Rizal issued on March 15, 2020, malls, bingo and lotto outlets, internet cafes, bars, coffee shops, cockpit arenas, except establishment inside malls providing basic services such as hospitals, clinics, pharmacies/drug stores, and groceries/supermarkets/palengkes and banks located therein, are encouraged to suspend their operations until the state of Public Emergency is lifted.

**SECTION 5.** Classes in all levels, both public and private are hereby suspended beginning March 20, 2020 until April 14, 2020, unless the suspension of classes is lifted if circumstances so warrant, subject, however, to the conditions imposed under paragraph B.1 of Resolution No. 11 s. 2020 of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID), which is, that all students shall continue to fulfill their educational requirements and that they shall remain in their homes during the period of suspension of classes.

For this purpose, the barangays are directed to monitor all establishments or places frequented by students in order to enforce this directive. Establishments are likewise encouraged to refuse entry to students who will go to their place or refuse rendering services to them.

**SECTION 6.** All government offices, private offices and all business establishments are encouraged to prevent their employees from reporting to work if they experience shortness of breath, fever, cough, cold and flu-like symptoms and have them stay home to be checked by doctors. They shall only be allowed to report back to work after presenting a medical certificate for this purpose.

Private individuals who are in contact with the public because of the nature of their work are also encouraged to do the same.

Likewise, all government and private offices may adopt a flexible worktime or workweek or maintain a skeletal force until the lifting of the state of public health emergency.

**SECTION 7.** Religious gatherings and rituals such as the celebration of the Holy Mass and worship activities, essential and important work-related meetings and gatherings or events that are unavoidable may proceed, *provided that* strict social distancing, which is the maintenance of at least one (1) meter radius between and among those attending, and other required protocols by the Department of Health are maintained and observed *provided further* that a list of the name of those who will attend an unavoidable event shall be submitted to the Municipal Health Office.

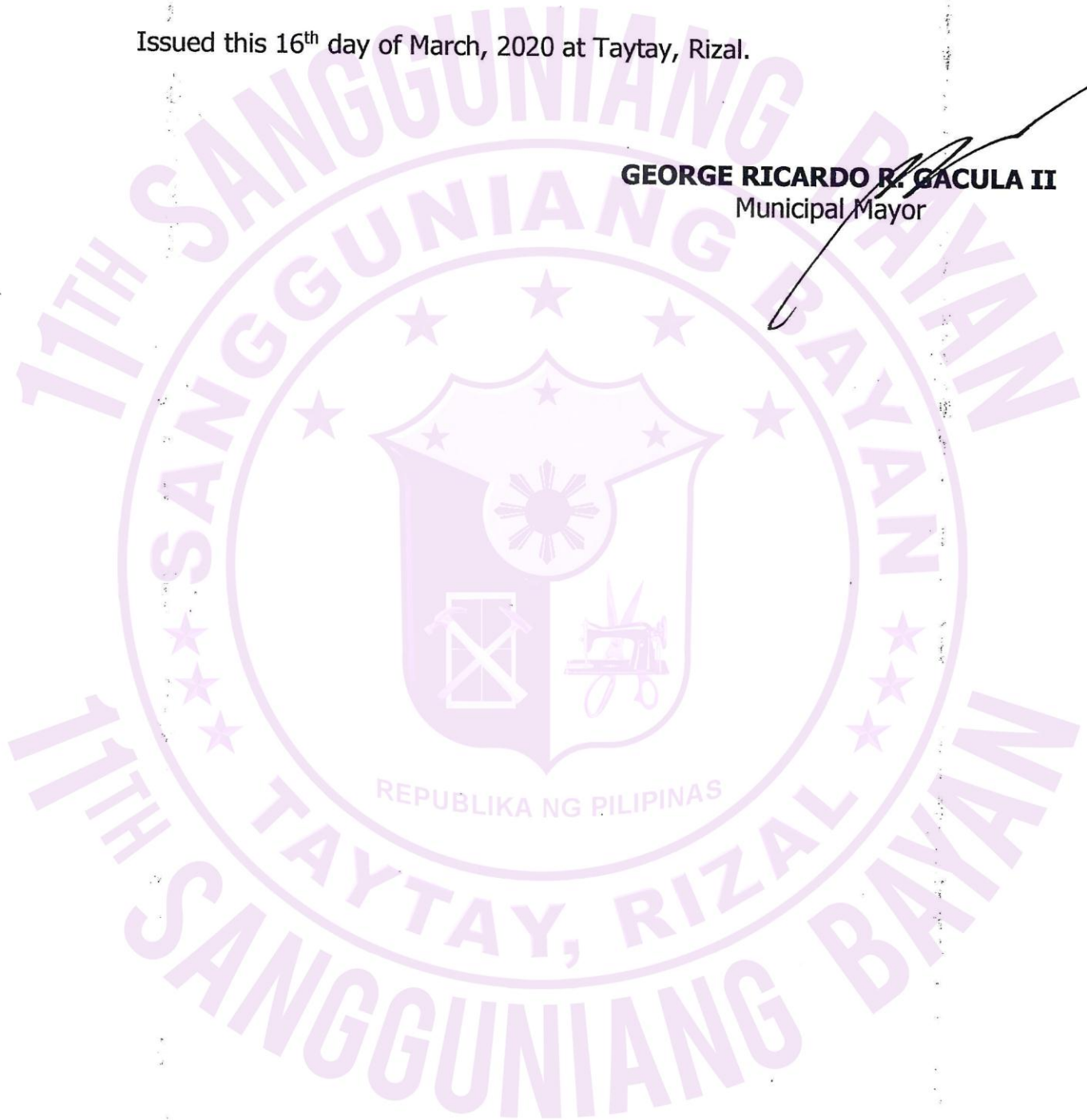
