A RESOLUTION GRANTING A ONE TIME CASH INCENTIVE IN THE AMOUNT OF TWO THOUSAND PESOS (PHP 2,000.00) EACH TO ALL BARANGAY NUTRITION SCHOLARS AND BARANGAY HEALTH WORKERS OF THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the State of Public Health Emergency has been declared by the President of the Republic of the Philippines, through Proclamation No. 992, following confirmed cases of total transmission of the 2019 Novel Coronavirus;

WHEREAS, the increasing rate of local transmission of the virus has prompted the President of the Republic, to issue and place the entire island of Luzon an enhance community quarantine;



WHEREAS, the lingering threat of the dreaded Novel Corona Virus 2019 has put the barangay nutrition scholars and barangay health workers into the frontline, making them more vulnerable to the threat of being exposed to the virus;

WHEREAS, government response and efforts to prevent, contain and mitigate the effect of the outbreak, demand the full mobilization of all local health workers at grassroot level which underline the significant role of the BNS and BHW in overall implementations of the local health measures to combat the same;

WHEREAS, recognizing the vital role which these local health workers assume to play during this perilous time, the Sangguniang Bayan deems it sound to provide support as incentive to their selfless services in the containment and prevention of the virus;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby grants A ONE TIME CASH INCENTIVE IN THE AMOUNT OF TWO THOUSAND PESOS (PHP 2,000.00) EACH TO ALL BARANGAY NUTRITION SCHOLARS AND BARANGAY HEALTH WORKERS OF THE MUNICIPALITY OF TAYTAY, RIZAL.
