## **RESOLUTION NO. 181 series of 2020**

**A RESOLUTION GRANTING A ONE TIME CASH INCENTIVE TO ALL THE  
PUBLIC HEALTH WORKERS OF THE MUNICIPALITY OF TAYTAY, RIZAL  
WHO RENDERED THEIR SERVICES DUTIES DURING AND IN RELATION  
TO COVID-19 HEALTH CRISIS**

WHEREAS, the State of Public Health Emergency all over the country, declared by the President of the Republic of the Philippines, under Proc. 922, has called out the concern apparatus of the government to enforce all protocols and measures related to the prevention, mitigation and containment of the spread of COVID-19.

WHEREAS, ingrained in the DILG and DOH Circulars, and more so in our statutes, that in all health-related issues and crisis, the local health personnel are most indispensable human capital that would serve as the backbone, on the implementation of any health measures.

WHEREAS, the risks are too high which cannot be quantified, that direct involvement in the arduous campaign to contain and defeat the COVID-19, and notwithstanding that exposure to the virus is quite apparent and potentially fatal, the local health workers had bravely and consciously ignored the same, all for the interest and welfare of the many.

WHEREAS, the local public health workers, must fittingly be accorded, if not deserving of recognition by the Sangguniang Bayan, for the tireless devotion to their duties they, being the primary bastion of the governmental machineries in protecting the health of the inhabitants of the municipality.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS A ONE TIME CASH INCENTIVE TO ALL THE PUBLIC HEALTH WORKERS OF THE MUNICIPALITY OF TAYTAY, RIZAL WHO RENDERED THEIR SERVICES DUTIES DURING AND IN RELATION TO COVID-19 HEALTH CRISIS.


RESOLVED FUTHER, that the Public Health Workers entitled to the subject incentive shall be verified and certified to, by the Municipal Health Officer to have rendered services during and in relation to the COVID-19 crisis.

RESOLVED FURTHERMORE, that the release of the incentive shall be effected as soon as the funds is available for the purpose.

RESOLVE MUCH FURTHERMORE, that a copy of this resolution be furnished to all concern offices of the Municipal Government of Taytay, Rizal.
