**A RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II TO GRANT THE REQUEST OF THE FIVE
BARANGAYS IN THE MUNICIPALITY OF TAYTAY FOR ANY FORM OF
ASSISTANCE TO AUGMENT THE BARANGAY RESOURCES NEEDED TO
HANDLE EFFECTIVELY THE THREAT OF THE POSSIBLE COVID-19
PANDEMIC**

WHEREAS, in compliance of the National Government of the Philippines to the World Health Declaration of COVID-19 Pandemic, thru the leadership of the Hon. President Rodrigo Duterte, several presidential proclamations and Circulars had cascaded in the locality thru the Department of Interior and Local Government;

WHEREAS, the Municipal Government of Taytay responsive of the act, had called the attention of the Barangay Concern in the locality recognizing them as the nearest and direct unit of the society in the community;

WHEREAS, during the 2nd Special Session of the 11th Sangguniang Bayan the members of the Liga ng mga Barangay of the five (5) barangays in the Municipality of Taytay had expressed their concerns on the preparation of the Municipal Government to control the possible harmful effect of COVID-19 to the constituents;

WHEREAS, the President of the Liga ng mga Barangay had formalize the concern to the August Body to collectively express and send their concern thru a resolution address to the Local Chief Executive;

NOW THEREFORE RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan in session hereby requests the Local Chief Executive to grant the request of the five barangays in the Municipality of Taytay for any form of assistance to augment the barangay resources needed to handle effectively the threat of possible COVID-19 Pandemic;

RESOLVED FURTHER, that copies of this resolution be sent to the Office of the Hon. Local Chief Executive George Ricardo R. Gacula II and other concerned offices and barangays for their information and appropriate action
