## RESOLUTION NO. 188 series of 2020

A RESOLUTION PRESCRIBING THE COMPOSITION AND GUIDELINES FOR IMPLEMENTATION OF ALL COVID-19 RELATED ORDINANCES FOR COMMUNITY INITIATED CHECKPOINTS WITHIN THE MUNICIPALITY OF TAYTAY

WHEREAS, upon the extension of the Luzon-wide Enhanced Community Quarantine, and placing of the Province of Rizal under lockdown and the growth of COVID-19 cases in the Philippines, many subdivisions, streets and areas have put up their own checkpoints and barriers that prevent non-residents to enter their communities;

WHEREAS, having community initiated checkpoints are favorable not only to the residents but also to the Barangays and the Municipal Government as it serves as force multipliers in preventing the spread of the disease, however, there have been reports that some of these checkpoints have volunteers ranging from 3 to 15 persons at a time;

WHEREAS, having a large number of persons manning these types of community initiated checkpoints can be considered as a social gathering and can do more harm than good when social distancing is neglected or when other activities other than checking of the people traversing the said checkpoints are being done;

WHEREAS, since there is an existing enhanced community quarantine and state of calamity, all community initiated checkpoints shall be in consultation with fellow residents and coordinated with the Barangay concerned and shall strictly follow all the existing rules and regulations of the Sangunniang Barangay and no solicitations for any checkpoints shall be allowed since all of these types of checkpoints are voluntary in nature;

WHEREAS, based on Executive Order No. 14 of the Provincial Government, minors are not allowed to roam outside and likewise senior citizens are the most at risk in contracting the disease thus the presence of minors and senior citizens at any checkpoints are deemed prohibited;

WHEREAS, it is but fitting to prescribe to all community initiated checkpoints to allow only up to four (4) persons maximum to guard their posts at any given time and shift and that community initiated checkpoints with more than 4 personnel present shall be considered as a form of social gathering thus violating the provision of the Enhanced Community Quarantine;

WHEREAS, Ordinance No. 27 series of 2020 states the mandatory wearing of masks at all times thus it is necessary for all personnel manning checkpoints to wear masks even when stationed or on duty;

WHEREAS, since the declaration of the Enhanced Community Quarantine it is required to carry a Home Quarantine Pass when going out for essential reasons thus the persons manning their community initiated checkpoint shall wear appropriate attire and have their own HQP and IDs and shall not allow their neighbors to go out of their barriers without presenting their Home Quarantine Passes;

WHEREAS, based on Section 21 of the Local Government Code, closure of roads can only be declared thru an Ordinance and based on DOH pronouncements only the DOH can declare lockdowns in areas of concerns thus the term lockdown shall not be used in any community initiated checkpoints;

WHEREAS, the composition of LGU, Barangay and PNP installed checkpoints are determined by the Municipal Government, the Sangguniang Barangay and the PNP respectively and is not affected by the prescription;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby PRESCRIBES THE COMPOSITION AND GUIDELINES OF IMPLEMENTATION OF ALL COVID-19 RELATED ORDINANCES FOR COMMUNITY INITIATED CHECKPOINTS WITHIN THE MUNICIPALITY OF TAYTAY.

RESOLVED FURTHER, that copies of this Resolution be furnished to the MPSO, GSO, all Sangguniang Barangays and Homeowners Association Officers for their information, proper guidance and appropriate action.

ADOPTED, this 14<sup>th</sup> day of April, 2020, 4:04 PM during the Online Session.
