**RESOLUTION ENDORSING TO THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II FOR A SUPPLEMENTAL FINANCIAL
ASSISTANCE FOR THE VULNERABLE AND MARGINALIZED SECTORS
THAT WERE NOT INCLUDED IN THE NATIONAL SOCIAL
AMELIORATION PROGRAM ALLOTMENT AND ANY FORM OF PENSION**

WHEREAS, Republic Act No. 11469 "Bayanihan to Heal as One Act" declaring a State of National Emergency throughout the Philippines, and declaring the urgent need to immediately mobilize assistance in the provisions of basic necessities to families and individuals affected by the imposition of community quarantine, especially indigents families, among others provides support interventions to all cases related to COVID-19;

WHEREAS, Presidential Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines and enjoining local government units to render full assistance, cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures to curtail COVID-19 threat;

WHEREAS, Joint Memorandum Circular No. 1, series of 2020 "Special Guidelines on the Provision of Social Amelioration Measures by the Department of Social Welfare (DSWD),

Department of Labor and Employment (DOLE), Department of Trade and Industry (DTI), Department of Agriculture (DA), Department of Finance Department of Budget and Management (DBM) and the Department of Interior and Local Government (DILG) to the most affected residents of the areas under enhanced community quarantine due to COVID-19 pandemic;

WHEREAS, DILG Memorandum Circular No. 2020-065 issued "Guidelines for Local Government Units in the Provision of Social Amelioration Measures by the National Government to the most affected residents of the areas under enhanced community quarantine;

WHEREAS, under the national social amelioration program, Municipality of Taytay was Allocated a total of 33,079 households from the 2015 PSA Census Survey of 73, 957 household data, which is 44.7% household included in the DSWD SAP, thus a higher number of which not included in said financial assistance;

WHEREAS, as per local data, this Municipality under Household Profiling Census / CBMS 2019-2020 target population approximately to 80,425 household, has registered 29,486 senior citizen, 5,000 persons with disability and 2,000 solo parents who are the most vulnerable and marginal sectors;

WHEREAS, under GAA (general appropriation act) the senior citizens and persons with disability are entitled to a 1% annual appropriation from the Internal Revenue Allotment (IRA) and 5% from total income of the LGU, allocated for Gender and Development (GAD) towards a gender responsive LGU for gender local government units, to implement programs, projects and service;


WHEREAS, numerous queries online and other means from various sectors who were not included in the lists of beneficiaries of the national social amelioration program, seeks assistance to be able to access same at the local government; hence this resolution is being proposed;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ENDORSE TO THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II FOR A SUPPLEMENTAL FINANCIAL ASSISTANCE FOR THE VULNERABLE AND MARGINALIZED SECTORS THAT WERE NOT INCLUDED IN THE NATIONAL SOCIAL AMELIORATION PROGRAM ALLOTMENT AND ANY FORM OF PENSION.
