RESOLUTION NO. 193 series of 2020

A RESOLUTION AUTHORIZING THE HON. GEORGE RICARDO R. GACULA II, MAYOR, TAYTAY, RIZAL, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT OR ANY OTHER FORM OF MUTUAL ARRANGEMENT WITH THE CITY GOVERNMENT OF MARIKINA, TO ACCOMODATE, PROCESS AND ASSESS SWAB SAMPLES OF SUSPECTED COVID 19 PATIENTS FROM TAYTAY, RIZAL, IN THE CITY'S COVID 19 LABORATORY/TESTING CENTER.

WHEREAS, the current health crisis, globally known as the COVID 19 pandemic, has widely contaminated communities all over the country and poses a serious threat to the health, safety and the lives of the general public, as their livelihood were adversely disrupted, that if not contained and prevented may lead to chaos and lawlessness.

WHEREAS, the outbreak of such dreaded virus, demands the mobilization of all the apparatuses and machineries of both the National and Local Government units, to flatten the curve and ultimately combat the same, devising means and draining the resources on hand, to soften the social and economic impact to its inhabitants.





WHEREAS, among the government responses and approaches sanctioned by health protocols of the Department Of Health is the setting up of laboratory for COVID 19 testing centers, which the Local Government Unit of Marikina City has initiated and was able to timely put up in place, paving the way for the conduct of the much needed mass testing, in order to identify and put to quarantine those found positive for COVID 19.

WHEREAS, the Municipal Government of Taytay, Rizal, a municipality adjacent to Marikina City, finds it encouraging to hear that the City Government of Marikina plans to share the services of the laboratory with other Local Government Units, prompting this Sangguniang Bayan to convey its interest in availing the same for its inhabitants.

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZE THE HON. GEORGE RICARDO R. GACULA II, MAYOR, TAYTAY, RIZAL, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT OR ANY OTHER FORM OF MUTUAL ARRANGEMENT WITH THE CITY GOVERNMENT OF MARIKINA, TO ACCOMODATE, PROCESS AND ASSESS SWAB SAMPLES OF SUSPECTED COVID 19 PATIENTS FROM TAYTAY, RIZAL, IN THE CITY'S COVID 19 LABORATORY/TESTING CENTER

RESOLVED FURTHER, that a copy of this resolution be furnished to the Office of the City Mayor and the Sangguniang Panglunsod of Marikina City, for their appropriate consideration, information and reference purposes.

RESOLVE FURTHERMORE, that the Memorandum of Agreement is subject for ratification of the Sangguniang Bayan before its full implementation.
