GACULA II; MAYOR, TAYTAY, RIZAL, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT OR ANY OTHER FORM OF MUTUAL ARRANGEMENT WITH THE "THE MEDICAL CITY", TO ACCOMODATE, PROCESS AND ASSESS SWAB SAMPLES OF SUSPECTED COVID 19 PATIENTS FROM TAYTAY, RIZAL, IN ITS LABORATORY.**

WHEREAS, the current health crisis, globally known as the COVID 19 pandemic, has widely contaminated communities all over the country and poses a serious threat to the health, safety and the lives of the general public, as their livelihood were adversely disrupted, that if not contained and prevented may lead to chaos and lawlessness.

WHEREAS, the outbreak of such dreaded virus, demands the mobilization of all the apparatuses and machineries of both the National and Local Government units, to flatten the curve and ultimately combat the same, devising means and draining the resources on hand, to soften the social and economic impact to its inhabitants.

WHEREAS, the Municipal Government of Taytay, Rizal is set to initiate and conduct mass testing for COVID 19 suspected patients including all Local Health Workers and other frontliners which under DOH protocols require that samples should still be tested in laboratories equipped with PCR machines.

WHEREAS, The Medical City, a health institution which is more accessible from Taytay, Rizal has facilities and laboratory equipped with PCR Machines to validate the results of swab samples taken through the use of Rapid Test Kits.


