RESOLUTION NO. 198 s. 2020

**A RESOLUTION RATIFYING THE MUNICIPAL DEVELOPMENT
EXECUTIVE COMMITTEE RESOLUTION 2020-003 REALIGNING THE FUNDS
FROM 20% DEVELOPMENT FUND FY 2020-FOR PROJECTS, PROGRAMS, AND
ACTIVITIES (PPA) ADDRESSING THE CORONA VIRUS DISEASE 2019 (COVID-19)
IN THE MUNICIPALITY OF TAYTAY**

WHEREAS, section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, the Municipal Development Council (MDC) shall assist the Sangguniang Bayan (SB) in setting the direction of development effort within the municipality;

WHEREAS, the DILG-DBM JMC No. 2017-1 dated February 22, 2017 prescribes guidelines on the allowable and prohibited development projects that may be charged under the 20% Development Fund;

WHEREAS, the Philippines was declared under the State of Public Health Emergency through issuance of Presidential Proclamation No. 922, s. 2020, and under the State of Calamity through the issuance of Proclamation No. 929, s. 2020 due to the Coronavirus Disease 2019 (Covid-19);

WHEREAS, the whole island of Luzon was placed under community quarantine last March 17, 2020 until April 12, 2020, and was extended until May 15, 2020;

WHEREAS, Section 4 of Bayanihan Heal as One Act of RA No. 11469 granted the President to adopt various temporary emergency measure to respond to crisis brought about by the pandemic;

WHEREAS, the LGU's were utilizing all possible resources available to provide various types of assistance for its constituents affected by the ECQ;

WHEREAS, the DILG and DBM released JMC No. 2020-001 allowing the utilization of the 20% Development Funds of the LGU for disaster preparedness and response efforts to contain the spread of COVID-19, and to continue to provide basic services to the affected population;

WHEREAS, listed below are the details of the projects/programs for realignment in the amount of Thirty-One Million Four Hundred Five Thousand Five Hundred Twenty- Five Pesos and Sixty-Five Centavos (P 31,405, 525.65) to wit:


