WHEREAS, due to COVID-19 Pandemic the Micro and Small Businesses in the municipality were affected and had to stop or lessen operation which affects the financial capability of the businesses in the locality;

WHEREAS, several programs and services had been provided by the National Government to assist them and let the economy roll back to the usual operation;

WHEREAS, the CARES Program is part of the National Administration's economic relief program for micro and small enterprises affected by the COVID-19 pandemic, under the program, micro and small enterprises operating for at least a year prior to March 16, 2020 and assets not exceeding P15 million can avail of the program and the Department of Trade and Industry spearhead in this assistance;

WHEREAS, this Municipality have almost 4,000 - 6,000 magti-tiangge and small businesses affected and has no permanent income for almost two (2) months;

WHEREAS, the Committee of Trade and Industry of the 11th Sangguniang Bayan supports and encourages the business owners to avail on this National Government Program;
