

RESOLUTION NO. 202 series of 2020

A RESOLUTION RATIFYING THE CONTRACT OF LEASE BY AND BETWEEN THE MUNICIPALITY OF TAYTAY REPRESENTED BY THE HON. MAYOR GEORGE RICARDO R. GACULA II AND NADAL MEAT SHOP REPRESENTED BY MR. CIRILO MATEO NADAL FOR THE MANAGEMENT AND OPERATION OF TAYTAY MUNICIPAL SLAUGHTERHOUSE

WHEREAS, there is a need for the proper management, operation and maintenance of the Taytay Municipal Slaughterhouse to ensure the quality of meat in the municipality;

WHEREAS, the Sangguniang Bayan of Taytay has adopted Resolution No. 200 series of 2020, authorizing the Local Chief Executive Hon. George Ricardo R. Gacula II of Taytay, Rizal to negotiate and enter and sign the Contract of Lease with Nadal Meat Shop for the management and operation of Taytay Municipal Slaughterhouse;

WHEREAS, the Contract of Lease was signed by both parties on June 1, 2020 and a Ratification is necessary before its full implementation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RATIFIES THE CONTRACT OF LEASE BY AND BETWEEN THE MUNICIPALITY OF TAYTAY REPRESENTED BY THE HON. MAYOR GEORGE RICARDO R. GACULA II AND NADAL MEAT SHOP REPRESENTED BY MR. CIRILO MATEO NADAL FOR THE MANAGEMENT AND OPERATION OF TAYTAY MUNICIPAL SLAUGHTERHOUSE.
