**RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF
BEST BINGO AND AMUSEMENT CORPORATION FOR THE
ESTABLISHMENT AND OPERATION OF A PHILIPPINE AMUSEMENT AND
GAMING CORPORATION ELECTRONIC GAMING OUTLET AT TAYTAY
CAPITAL TIANGGE, HIGHWAY 2000 CORNER MARKET ROAD,
BARANGAY SAN JUAN, IN THE MUNICIPALITY OF TAYTAY, PROVINCE
OF RIZAL**

WHEREAS, this August Body received a letter from Mr. Louie B. Capuno, requesting for a resolution interposing no objection to the establishment of a Philippine Amusement and Gaming Corporation (PAGCOR) Electronic Bingo Outlet at Taytay Capital Tiangge, Highway 2000 corner Market Road, Barangay San Juan, Taytay, Rizal;

WHEREAS, the Municipality of Taytay considers gambling generally unfavorable to the interests of the people. However, there are national laws, which allows the operation of certain games of chance and which the Municipality of Taytay cannot prohibited, but such activities even if considered legal are subject to the regulatory powers of the local government unit concerned;

WHEREAS, a resolution of no objection from the Sangguniang Bayan is one of the requirements by PAGCOR to allow operation of such gaming establishment;

WHEREAS, **BEST BINGO AND AMUSEMENT CORPORATION** has committed itself to comply strictly with the existing and applicable rules, resolution, ordinances and other regulation of Best Bingo and Amusement Corporation for the establishment and operation of PAGCOR approved electronic gaming outlet in the Municipality of Taytay, Province of Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby INTERPOSES NO OBJECTION TO THE APPLICATION OF BEST BINGO AND AMUSEMENT CORPORATION FOR THE ESTABLISHMENT AND OPERATION OF PAGCOR-APPROVED ELECTRONIC GAMING OUTLET IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.


RESOLVED FURTHER, that copies of Resolution be furnished to the Office of the Mayor, the Municipal Legal Office and all other concerned offices for their information and appropriate action.

RESOLVED FURTHERMORE, any violation committed by the BEST BINGO AND AMUSEMENT CORPORATION shall be subject for the revocation of permit to operate.

RESOLVED FURTHERMOST, the permit to operate shall be renewable every three (3) years to the Sangguniang Bayan.
