**A RESOLUTION AMENDING RESOLUTION NO. 400 SERIES OF 2019,  
REALIGNING THE PROJECT LOCATION FROM THE PREVIOUS ADDRESS  
BLOCK 31 TO BLOCK 17, LOT 791 ABC, MATULUNGIN ST., PUROK 3,  
LUPANG ARENDA, BARANGAY STA. ANA, TAYTAY, RIZAL AND  
REPLACING THE REPRESENTATIVE OF SMART COMMUNICATIONS, INC.  
FROM MR. ARIEL G. AZNAR TO MS. DEBBIE M. HU, DEPARTMENT  
HEAD/VP., OFFICE OF NETWORK OPERATIONS HEAD IN CONNECTION TO  
THE CONSTRUCTION, INSTALLATION AND OPERATION OF CELLSITE

WHEREAS, the 10<sup>th</sup> Sangguniang Bayan of Taytay, Rizal passed Resolution No. 400 series of 2019 entitled: "A Resolution Authorizing the Local Chief Executive Honorable George Ricardo R. Gacula II in behalf of the Municipality of Taytay, Rizal to enter into a Memorandum of Agreement with Smart Communication Incorporated through its duly representative Mr. Ariel G. Aznar, Center Head/AVP for the Construction, Installation and Operation of Cellsite Tower Facility located at Lupang Arenda, Barangay Sta. Ana, Taytay, Rizal" last March 28, 2019;



WHEREAS, the Sangguniang Bayan received a letter from Ms. Josephine Jimenez, Site Acquisition of Huawei Technologies Inc. last March 10, 2020 requesting for the amendment of Resolution No. 400 series of 2019;

WHEREAS, the previous project location is within the bounds of The Southeast Metro Manila Expressway (SEMME), also known as C6 Expressway and Skyway Stage 4 thus the need to be re-located;

WHEREAS, the Sangguniang Bayan acknowledges Ms. Debbie M. Hu, Department Head/VP., Office of Network Operations Head as the new duly approved Representative of Smart Communications, Inc. for the signing of the MOA for the construction, installation and operation of cellsite tower facility located at Lupang Arenda, Barangay Sta. Ana, Taytay, Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AMENDS RESOLUTION NO. 400 SERIES OF 2019, REALIGNING THE PROJECT LOCATION FROM THE PREVIOUS ADDRESS BLOCK 31 TO BLOCK 17, LOT 791 ABC, MATULUNGIN ST., PUROK 3, LUPANG ARENDA, BARANGAY STA. ANA, TAYTAY, RIZAL AND REPLACING THE REPRESENTATIVE OF SMART COMMUNICATIONS, INC. FROM MR. ARIEL G. AZNAR TO MS. DEBBIE M. RESOLVED FURTHER, that this resolution supersedes Resolution No. 400 series of 2019 and Resolution No. 101 series of 2019.


RESOLVED FURTHERMORE, that the Smart Communications, Inc. must secure the necessary permit before the construction or installation of the cellsite.
