RESOLUTION NO. 207 series of 2020

A RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT OF THE 3RD AND 4TH QUARTER BUSINESS TAXES, FEES AND CHARGES UP TO SEPTEMBER 20, 2020 FOR THE 3RD QUARTER AND NOVEMBER 20, 2020 FOR THE 4TH QUARTER RESPECTIVELY WITHOUT PENALTIES, SURCHARGES AND INTERESTS.

WHEREAS, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, or charges without penalties, surcharges and interests but only for a period not exceeding six (6) months;

WHEREAS, in the light of the Proclamation No. 929, declaring a state of calamity throughout the Philippines due to Corona Virus Disease 2019 (COVID-19) this Sanggunian is compelled to adapt such Resolution;

WHEREAS, Proclamation No. 922, Series of 2020 was issued declaring a State of Public Health Emergency throughout the Philippines due to COVID-19, enjoining all government agencies and Local Government Units (LGUs) to render full assistance and cooperation;

WHEREAS, Resolution No. 179 Series of 2020 declared that the Municipality of Taytay is in a State of Calamity pursuant to section 447 of the Local Government Code;

WHEREAS, considering that the Municipality is continually under the state of General Community Quarantine (GCQ) most business establishments are still in partial operation thus there is a need to extend the deadline for the payment of business taxes, fees and charges for the 3rd and 4th Quarter of 2020;

WHEREAS, this Resolution likewise considers this extension as a form of relief extended by the LGU to its constituents;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXTENDS THE DEADLINE FOR THE PAYMENT OF THE 3RD AND 4TH QUARTER BUSINESS TAXES, FEES AND CHARGES UP TO SEPTEMBER 20, 2020 FOR THE 3RD QUARTER AND NOVEMBER 20, 2020 FOR THE 4TH QUARTER RESPECTIVELY WITHOUT PENALTIES, SURCHARGES AND INTERESTS.

RESOLVED FUTHER, that copies be furnished to all concerned for their information and appropriate action.
