MADONNA GARCIA TO ASSIGN AN OFFICE SPACE OR A CLASSROOM TO SERVE AS HEADQUARTERS FOR THE 2020 CENSUS OF POPULATION AND HOUSING FOR THIS MUNICIPALITY**

WHEREAS, Batas Pambansa Blg. 72 which is an Act providing for an Integrated Census every ten years beginning 1980 is due to commence nationally this year, 2020;

WHEREAS, DILG Memorandum Circular No. 2020-044 enjoins all Local Government Units to provide assistance and support to the 2020 Census of Population and Housing to be conducted by the Philippine Statistics Authority as mandated in RA10625 or the Philippine Statistical Act of 2013;

WHEREAS, having an accurate and credible results of the Census will greatly benefit the Municipality of Taytay in terms of better planning and implementation of both local and national



programs and be advantageous to our communities in terms of economic allocations, education, health services, social services, public works and other vital government projects and aids as evidenced during the current pandemic;

WHEREAS, the would be trained Enumerators and Census Area Supervisors will be 100% Taytayenos and will be needing an accessible Headquarters in Taytay for them to easily access the forms, bags and all materials necessary for the census instead of going back and forth to the Provincial Office in San Jose, Antipolo City;


WHEREAS, the needed Headquarters will only be used by the Taytay Census team for approximately 2 to 3 months from August up to September or October only during office hours and minimum health standards and other COVID-19 safety and health protocols shall be strictly observed at all times;
