RESOLUTION NO. 211 series of 2020

APPROVING AND RATIFYING THE MDC RESOLUTION NO. 2020 - 004 ENTITLED: "A RESOLUTION RECOMMENDING ADOPTION OF THE ANNUAL INVESTMENT PROGRAM (AIP) FY 2020 - SUPPLEMENTAL AMOUNTING TO ONE HUNDRED SIXTY TWO MILLION ONE HUNDRED THIRTY THOUSAND NINETY NINE PESOS AND TWENTY NINE CENTAVOS (P 162,130,099.29)"

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, the President has declared the whole Nation under the State of Public Health Emergency through Presidential Proclamation No. 922 s. 2020 and under the State of Calamity through Proclamation No. 929 s. 2020 due to the Corona Virus Disease 2019 (COVID-19);

WHEREAS, the LGUs were utilizing all possible resources available to provide various types of assistance for its constituents affected by the General Community Quarantine;

WHEREAS, item 2.3 of the DILG and DBM Joint Memorandum Circular (JMC) No. 1 last March 27, 2020 states that: "All COVID-19 related expenses to be funded by the LGUs should be part of their Annual Investment Program (AIP);

WHEREAS, in case the COVID-19 related expenses are not among those included in the approved Annual Investment Program (AIP) the local development council shall prepare a supplemental investment program for the purpose;

WHEREAS, submitted and presented before this Honorable August Body for review and consideration the Municipal Development Council (MDC) Resolution No. 2020 - 004 recommending adoption of the Annual Investment Program (AIP) FY 2020 - Supplemental amounting to One Hundred Sixty-Two Million One Hundred Thirty Thousand Ninety-Nine Pesos and Twenty-Nine Centavos (P 162,130,099.29);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES THE MDC RESOLUTION NO. 2020 - 004 ENTITLED: "A RESOLUTION RECOMMENDING ADOPTION OF THE ANNUAL INVESTMENT PROGRAM (AIP) FY 2020 - SUPPLEMENTAL AMOUNTING TO ONE HUNDRED SIXTY TWO MILLION ONE HUNDRED THIRTY THOUSAND NINETY NINE PESOS AND TWENTY NINE CENTAVOS (P 162,130,099.29)".
