## **RESOLUTION NO. 212 series of 2020**

**APPROVING AND RATIFYING THE MDC RESOLUTION NO. 2020 - 005 ENTITLED: "A RESOLUTION REALIGNING THE AMOUNT OF TEN MILLION FIVE HUNDRED FORTY THREE THOUSAND NINETY ONE PESOS AND TWENTY NINE CENTAVOS (Php 10,543,091.29) FROM THE 20% DEVELOPMENT FUND FY 2020 TO PRIORITY PROJECT AND OTHER VARIOUS PROJECTS, PROGRAMS AND ACTIVITIES (PPAs) ADDRESSING THE CORONA VIRUS DISEASE 2019 (COVID-19) IN THE MUNICIPALITY OF TAYTAY"**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, the President has declared the whole Nation under the State of Public Health Emergency through Presidential Proclamation No. 922 s. 2020 and under the State of Calamity through Proclamation No. 929 s. 2020 due to the Corona Virus Disease 2019 (COVID-19);



WHEREAS, the LGUs were utilizing all possible resources available to provide various types of assistance for its constituents affected by the General Community Quarantine;

WHEREAS, the DILG and DBM released JMC No. 2020-001 allowing the utilization of the 20% Development Funds of the LGU for disaster preparedness and response efforts to contain the spread of COVID-19, and to continue to provide basic services to the affected population;

WHEREAS, submitted to the Honorable August Body is Municipal Development Council (MDC) Resolution No. 2020 – 005 for approval and ratification;


RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
