RESOLUTION NO. 213 series of 2020

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR GEORGE RICARDO R. GACULA II TO REPRESENT THE MUNICIPAL GOVERNMENT OF TAYTAY TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY AND THE PILIPINAS TODA CORPORATION, AND FOR OTHER PURPOSES

WHEREAS, Section 9 of Article II of the 1987 Constitution provides that: "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from the poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all";

WHEREAS, Section 20 of the same article provides that: "The State recognizes the indispensable role of the private sector, encourages private enterprises, and provides incentives to needed investments";





WHEREAS, Section 16 of Republic Act 7160 (Local Government Code of 1991) provides that: "Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and convenience of their inhabitants";

WHEREAS, Section 35 of the Republic Act 7160 (Local Government Code of 1991) encourages the participation of the private sector in local governance particularly in the delivery of basic services;

WHEREAS, RA 7160 likewise provides that the local chief executive shall represent the municipality in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance:

WHEREAS, the Sangguniang Bayan shall exercise other powers and perform such other duties and functions as may be prescribed by law for the general welfare of the City and its inhabitants pursuant to Section 447 (a) Republic Act 7160 (Local Government Code of 1991), to wit:

Section 447. Power, Duties, Functions, and Compensation

"(a) The Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code xxx" South

WHEREAS, under Section 444 (b)(1)(vi) of Republic Act 7160 (Local Government Code of 1991), a Municipal Mayor is required to secure the prior authorization of the Sangguniang Bayan before entering into a contract in behalf of the municipality:


"(vi) Upon authorization by the Sangguniang Bayan, represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance:"

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan in a session duly assembled, hereby AUTHORIZES THE HONORABLE MAYOR GEORGE RICARDO R. GACULA II TO REPRESENT THE MUNICIPAL GOVERNMENT OF TAYTAY TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY AND THE PILIPINAS TODA CORPORATION, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for information and appropriate action.
