**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II TO ENTER INTO MEMORANDUM OF
AGREEMENT WITH DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS
(DPWH) THROUGH THE RIZAL 1ST DISTRICT ENGINEERING OFFICE
(RIZAL 1ST DEO) FOR THE CONSTRUCTION OF QUARANTINE/ISOLATION
FACILITIES IN BARANGAY STA. ANA OF THIS MUNICIPALITY**

WHEREAS, on August 2, 2020, President Rodrigo Roa Duterte placed Metro Manila and the Province of Laguna, Cavite, Rizal and Bulacan under a Modified Enhance Community Quarantine (MECQ);

WHEREAS, IATF Resolution No. 60-A 6(d) directs all provinces, HUCs and ICCs of NCR and Region 4-A to scale up local health system capacity, especially for community isolation and critical care, including dedicated mechanical ventilators, ICU, isolation, and ward beds for COVID-19 cases;

WHEREAS, the prevalence of the COVID-19 Public Health Crisis prompted the DPWH's assistance in constructing quarantine/isolation facilities to alleviate the daily operational challenges during crisis;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan in a session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THROUGH THE RIZAL 1ST DISTRICT ENGINEERING OFFICE (RIZAL 1ST DEO) FOR THE CONSTRUCTION OF QUARANTINE/ISOLATION FACILITIES IN BARANGAY STA. ANA OF THIS MUNICIPALITY.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for information and appropriate action.
