RESOLUTION NO. 217 series of 2020

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND TRANSPORTATION OFFICE (LTO) REGION IV-A FOR THE ASSIGNMENT OF JOB ORDER PERSONNEL IN THE LTO EXTENSION OFFICE IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the LTO is strengthening law enforcement through establishment of offices and catering of various Land Transportation Services;

WHEREAS, there is a need to put up Land Transportation Office (LTO) in Taytay, Rizal that will benefit the residents particularly those owners of vehicles, public and private;





WHEREAS, the 11th Sangguniang Bayan passed Resolution No. 14, series of 2019 last August 13, 2019; requesting Assistant Secretary Edgar C. Galvante thru Executive Director Atty. Romeo G. Vera Cruz to Open an LTO Extension Office in Taytay, Province of Rizal:

WHEREAS, the establishment of an LTO Extension Office in the Municipality necessitates the services of Job Order Personnel;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND TRANSPORTATION OFFICE (LTO) REGION IV-A FOR THE ASSIGNMENT OF JOB ORDER PERSONNEL IN THE LTO EXTENSION OFFICE IN THE MUNICIPALITY OF TAYTAY, RIZAL.
