RESOLUTION NO. 220 series of 2020

**A RESOLUTION AUTHORIZING MAYOR GEORGE RICARDO R. GACULA II,
TO CAUSE THE DEMOLITION OF THE OLD MUNICIPAL BUILDING OF
TAYTAY, RIZAL LOCATED AT RIZAL AVENUE, CORNER KADALAGAHAN
STREET AND COVERED BY TAX DECLARATION NO. 18-TY-002-08242**

WHEREAS, the promotion of the health of Taytayeños through the effective delivery of health services and the establishment of health facilities is among the priorities of the Municipal Government of Taytay;

WHEREAS, on August 20, 2019, the 11th Sangguniang Bayan of Taytay, Rizal adopted Resolution No. 15 series of 2019 entitled: "A Resolution humbly requesting Honorable Rebecca A. Ynares, Governor of Rizal Province to construct and manage a Provincial General Hospital in the Municipality of Taytay, Rizal", that would make access to medical care and health services

more convenient not only to the constituents of Taytay but also to the residents of the nearby Municipalities;

WHEREAS, on September 02, 2019, in response with the request and finding the same as consistent with the thrust of the Rizal Provincial Government to ensure the delivery of basic health services to the Rizaleños, the 29th Sangguniang Panlalawigan ng Rizal adopted Resolution No. 421, series 2019 entitled: "A Resolution Approving the Establishment of Rizal Provincial Hospital System (RPHS)-Taytay Annex";

WHEREAS, consistent with its undertaking that the Municipality of Taytay may provide land to be used for the construction of the hospital, free from any liens or encumbrances or whatever of the same kind, hence, on October 08, 2019, the 11th Sangguniang Bayan of Taytay Rizal adopted Resolution No. 84 series of 2019 entitled: "A Resolution designating as the property site for the construction of the Rizal Provincial Hospital System (RPHS) - Taytay Annex the parcels of land covered by Tax Declaration Nos. 18-TY-002-08242 and 18-TY-001-12950;

WHEREAS, under the same Resolution No. 84 series of 2019, the Municipal Government of Taytay, Rizal further undertakes to be responsible for the removal of any building or structure constructed in the subject lands, as well as the issuance of necessary clearance or permit in the use of the municipal road adjoining the subject parcels of land;

WHEREAS, on June 29, 2020, Hon. George Ricardo R. Gacula II, Municipal Mayor, Taytay Rizal, issued Executive Order No. 130, s. 2020, Creating a Committee for the divestment or disposal of unserviceable property no longer needed by the Municipality of Taytay, Rizal;

WHEREAS, in a letter by the Municipal Engineer to Mayor George Ricardo R. Gacula II on August 5, 2020, it was stated that the Old Municipal Building had been condemned twice, sometime in 2001 and 2007 and that despite of its repair sometime in 2016, the problems on water leaks, improper electrical installations, obsolescence and its possibility of being a fire trap were not addressed;


WHEREAS, to avert the imminent risk and danger it poses to the life and safety of those occupying or using the Old Municipal Building, the same should be demolished;

WHEREAS, the demolition of the Old Municipal Building will pave the way for the construction of the Rizal Provincial Hospital System (RPHS) - Taytay Annex;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES MAYOR GEORGE RICARDO R. GACULA II, TO CAUSE THE DEMOLITION OF THE OLD MUNICIPAL BUILDING OF TAYTAY, RIZAL LOCATED AT RIZAL AVENUE, CORNER KADALAGAHAN STREET AND COVERED BY TAX DECLARATION NO. 18-TY-002-08242.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information, guidance and appropriate action.
