A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE MUNICIPALITY OF TAYTAY, RIZAL REPRESENTED BY THE MUNICIPAL MAYOR HON. GEORGE RICARDO R. GACULA II WITH PILIPINAS TODA CORPORATION (TODA PH) REPRESENTED BY ITS PRESIDENT MR. ERIC R. CRUZ, FOR THE PROVISION OF TRICYCLE RIDE-HAILING APPLICATION SERVICES TO THE CONSTITUENTS OF TAYTAY, RIZAL

WHEREAS, the 11th Sangguniang Bayan had adopted Resolution 213, series of 2020 entitled a Resolution Authorizing the Honorable Mayor George Ricardo R. Gacula II to represent the Municipal Government of Taytay to sign the Memorandum of Agreement between the Municipal Government of Taytay and the Pilipinas TODA Corporation, and for other purposes;

WHEREAS, the Memorandum of Agreement between the Municipality of Taytay, Rizal represented by the Hon. Mayor George Ricardo R. Gacula II and Pilipinas TODA Corporation
