OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AS A NOMINEE FOR THE "GAWAD SA MANLILIKHA NG BAYAN AWARD" OR THE NATIONAL LIVING TREASURES AWARD OF THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA)

WHEREAS, the Gawad sa Manlilikha ng Bayan or the National Living Treasures Award was institutionalized through Republic Act No. 7355, the National Commission for Culture and the Arts, the highest policy-making and coordinating body for culture and the arts of the award, through the Gawad sa Manlilikha ng Bayan Executive Council, who will conduct the search for the finest traditional artists of the land, adopts a program that will ensure the transfer of their skills to others, and undertakes measures to promote a genuine appreciation of and instill pride among our people about the genius of the Manlilikha ng Bayan;

WHEREAS, the Provincial Tourism Council and Office had informed the Local Tourism Council of Taytay to nominate a candidate amongst our constituents who excel in their field

showing promotion of traditional art in the locality and the Municipal Tourism Council and Office will be nominating visual artist MR. GODOFREDO F. ZAPANTA, SR. on this category;

WHEREAS, the NCCA opens the nomination for the search for Gawad sa Manlilikha ng Bayan artist until February, 2021 and it is of great honor that Mr. Godofredo F. Zapanta, Sr., Filipino born and a native of Taytay will be nominated as an awardee of Gawad sa Manlilikha ng Bayan, he has genuine love for arts and it came and was nurtured first as a freelance comic Illustrator, then to a local business entrepreneur in art works and services, and then eventually became a freelance visual artist conducting major works, performances and exhibits (categorized as two-men, group and later on solo exhibits), he possesses a mastery of tool and materials needed for visual arts and maker of works of extraordinary technical quality;

WHEREAS, Mr. Godofredo F. Zapanta, Sr., showed excellence in every art works he had portrayed and he served as an inspiration to level up the awareness of his Kababayans especially the interest of youths working on arts and other art enthusiasts;

WHEREAS, the Municipal Officials find his art works and masterpiece worth being proud for, and it served as wall painting displayed in the Municipal Government Hall of the locality since 2008;


