## **RESOLUTION NO. 233 series of 2020**

A RESOLUTION ADOPTING THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) COVERING THE YEARS 2020 – 2022 AMOUNTING TO SEVEN BILLION THREE HUNDRED SEVENTEEN MILLION EIGHT HUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED FIFTY-THREE PESOS AND TWO CENTAVOS (P 7,317,868,853.02)"

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, there is a need for the formulation of Local Development Investment Program (LDIP) CY 2020 – 2022 for the development of this municipality in terms of social, economic, environment, administrative governance and by implementing the fundamentals of good governance;





WHEREAS, submitted and presented before this Honorable August Body is Municipal Development Council (MDC) Resolution No. 2020 – 007 entitled: "A Resolution Recommending Adoption of the Local Development Investment Program (LDIP) covering the Years 2020 – 2022 amounting to Seven Billion Three Hundred Seventeen Million Eight Hundred Sixty-Eight Thousand Eight Hundred Fifty-Three Pesos and Two Centavos (P 7,317,868,853.02);

WHEREAS, the Local Development Investment Program (LDIP) contains a prioritized list of programs, projects and activities which are derived from the Comprehensive Development Program (CDP) of the Municipality, to be implemented within a three (3) year period, 2020 – 2022;

WHEREAS, the programs, projects and activities incorporated in the LDIP are supportive of the development goals and thrusts of this Municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) COVERING THE YEARS 2020 – 2022 AMOUNTING TO SEVEN BILLION THREE HUNDRED SEVENTEEN MILLION EIGHT HUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED FIFTY-THREE PESOS AND TWO CENTAVOS (P 7,317,868,853.02)".
