RESOLUTION NO. 234 series of 2020

A RESOLUTION APPROVING AND RATIFYING THE AMENDED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2020 OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, on December 17, 2019, the Sangguniang Bayan of Taytay passed Resolution No 129 series of 2019 entitled: "A Resolution Approving and Ratifying Municipal Development Council (MDC) Resolution No. 2019 – 004 A Resolution Recommending Adoption of the Annual Investment Program (AIP) CY 2020 amounting to Four Billion Seven Million Nine Hundred Seven Thousand Eight Hundred Seventy-Nine Pesos and Forty-Seven Centavos (Php 4,007,907,879.47)";

WHEREAS, the President has declared the whole Nation under the State of Public Health Emergency through Presidential Proclamation No. 922 s. 2020 and under the State of Calamity through Proclamation No. 929 s. 2020 due to the Corona Virus Disease 2019 (COVID-19);

WHEREAS, item 2.3 of the DILG and DBM Joint Memorandum Circular (JMC) No. 1 last March 27, 2020 states that: "All COVID-19 related expenses to be funded by the LGUs should be part of their Annual Investment Program (AIP);

WHEREAS, in case the COVID-19 related expenses are not among those included in the approved Annual Investment Program (AIP) the local development council shall prepare a supplemental investment program for the purpose;

WHEREAS, last July 21, 2020, the Sangguniang Bayan of Taytay passed Resolution No. 211 series of 2020; "Approving and Ratifying the MDC Resolution No. 2020 – 004 entitled: A Resolution Recommending Adoption of the Annual Investment Program (AIP) FY 2020 – Supplemental amounting to One Hundred Sixty-Two Million One Hundred Thirty Thousand Ninety-Nine Pesos and Twenty-Nine Centavos (P 162,130,099.29);

WHEREAS, the Local Government of Taytay, Rizal made a letter addressed to President Rodrigo Duterte requesting for a fund for the illumination of the main road in the municipality;

WHEREAS, as per advice of the Department of Budget and Management (DBM), the Mayor was informed that his request for fund for the project: "Proposed Purchase and Installation of LED Streetlights at Rizal Avenue, Taytay, Rizal", has been approved in the amount of Four Million Pesos (P 4,000,000.00);

WHEREAS, last September 22, 2020, the Sangguniang Bayan of Taytay passed Resolution No. 227 series of 2020; "Approving and Ratifying the MDC – Executive Committee Resolution No. 2020 – 006 entitled: A Resolution Amending the Annual Investment Program (AIP) CY 2020 to add the Proposed Purchase and Installation of LED Streetlights at Rizal Avenue, Taytay, Rizal amounting to Four Million Pesos (P 4,000,000.00);

WHEREAS, there is a need to approve and ratify the amended Annual Investment Program (AIP) of the Municipality of Taytay, Province of Rizal for the Calendar Year 2020;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFY THE AMENDED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2020 OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
