**A RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II TO EXTEND ASSISTANCE IN ANY FORM
TO ALL LEARNERS WITH SPECIAL EDUCATION NEEDS, PERSON WITH
DISABILITY UNDER 15 YEARS OF AGE, AND DAY CARE CENTER
STUDENTS WHO ARE RESIDING IN TAYTAY, RIZAL TO SUSTAIN THEIR
NEEDS DURING THIS PERIOD OF PANDEMIC**

WHEREAS, Article XV, Section 3(2) of the 1987 Constitution of the Republic of the Philippines implores that "the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development.";

WHEREAS, Section 16 of the General Welfare Clause of RA 7160, provides in part that every Local Government Units shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, this Municipality enacted Ordinance 31, series of 2015 entitled “An Ordinance Enacting the Children’s Code of this Municipality of Taytay, Rizal” of which all assistance to children was fully recognized;

WHEREAS, the 912 Persons with Disability under 15 years of age, the 200 more or less Learners with Special Education Needs enrolled in Rosario Ocampo Elementary School (ROES), Sta Ana Elementary School, Casimiro A. Ynares Sr. Memorial National High School and Taytay Senior High School, and 800 more or less Students of 48 Day Care Centers who are residents of this Municipality will benefit this kind of assistance;

WHEREAS, the GAD Focal Point System allocated a budget for children under the Municipal Gender and Development (GAD) Plan and Budget of Fiscal Year 2020 under the Municipal Social Welfare and Development Office;


WHEREAS, the Municipal Government of Taytay were utilizing all possible resources available to provide various types of assistance for its constituents affected by the pandemic;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO EXTEND ASSISTANCE IN ANY FORM TO ALL LEARNERS WITH SPECIAL EDUCATION NEEDS, PERSON WITH DISABILITY UNDER 15 YEARS OF AGE, AND DAY CARE CENTER STUDENTS WHO ARE RESIDING IN TAYTAY, RIZAL TO SUSTAIN THEIR NEEDS DURING THIS PERIOD OF PANDEMIC.
