## RESOLUTION NO. 238 series of 2020

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO DONATE ON BEHALF OF THIS MUNICIPALITY THE AMOUNT OF FIFTY THOUSAND PESOS (PHP 50,000.00) TO THE LOCAL GOVERNMENT OF THE MUNICIPALITY OF GUINOBATAN, PROVINCE OF ALBAY, BICOL REGION, FOR THE VICTIMS OF SUPER TYPHOON ROLLY**

WHEREAS, the Super Typhoon Rolly that occurred last November 1, 2020 has gravely affected Region V - Bicol Region particularly the Municipality of Guinobatan, Province of Albay;

WHEREAS, the Province of Albay has already declared State of Calamity following the initial assessment of the damage caused by the super typhoon;

WHEREAS, there were four thousand four hundred thirteen (4,413) families who evacuated from those areas affected by the super typhoon and now in dire need of any form of

assistance from those who might be minded to intervene and respond, so as to soften the impact of the calamity which disrupted the livelihood and destroyed the properties of the residents thereat;

WHEREAS, the Members of the Sangguniang Bayan have agreed to provide an immediate assistance in those affected municipalities through monetary donation in the amount of Fifty Thousand Pesos (Php 50,000.00);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R.
