SCMC GROUP OF SM PRIME HOLDINGS, INC. REGARDING THE FREE
MOVIE WATCH OF THE SENIOR CITIZENS IN THE MUNICIPALITY OF
TAYTAY, RIZAL**

WHEREAS, the Senior Citizens of this Municipality presently avails free movie watch at SM City Taytay as their additional privilege and benefit based on Resolution No. 85 series 2008 and amended Resolution No. 126 series of 2014;

WHEREAS, the Senior Citizens of this Municipality were given preferential attention and priority to enjoy additional grant of incentive as an expression of gratitude to their invaluable contribution to the progress and prosperity of the Municipality of Taytay;

WHEREAS, all Senior Citizens of Taytay are eligible to watch a movie in SM City Taytay Cinema free of charge;

WHEREAS, the former Memorandum of Agreement has already expired last Friday, October 30, 2020 by which the Senior Citizens free movie watch will be affected;


WHEREAS, this Memorandum of Agreement with SM City Taytay that is subject for negotiation and shall be entered into by the Local Chief Executive, Hon. George Ricardo R. Gacula II is for the continuity of the free movie watch for our Elders or Senior Citizens;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. REGARDING THE FREE MOVIE WATCH OF THE SENIOR CITIZENS IN THE MUNICIPALITY OF TAYTAY, RIZAL.
