WHEREAS, a parcel of land located at Sitio Bato-Bato Malaking Parang, Barangay San Juan, this municipality is owned and registered under the name of Mr. Edwin De Leon;

WHEREAS, the owner has executed a Deed of Donation involving the said property which is particularly covered by Tax Declaration No. 18-TY-00404369 and with an area of 64 square meters;

WHEREAS, expressly stipulated in the Deed of Donation is the condition that bar the use of the subject lot for any purpose other than for drainage or passage way of water;


