OF TRICYCLE RIDE-HAILING APPLICATION SERVICES TO THE

WHEREAS, the 11th Sangguniang Bayan had adopted Resolution 237, series of 2020 entitled a Resolution Authorizing the Honorable Mayor George Ricardo R. Gacula II to represent the Municipal Government of Taytay to sign the Memorandum of Agreement between the Municipal Government of Taytay and the Golden 9 Mapples TODA Corporation, and for other purposes;
