## RESOLUTION NO. 246 series of 2020

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO DONATE ON BEHALF OF THIS MUNICIPALITY THE AMOUNT OF FIFTY THOUSAND PESOS (PHP 50,000.00) TO THE CITY GOVERNMENT OF TUGUEGARAO, PROVINCE OF CAGAYAN, FOR THE VICTIMS OF TYPHOON ULYSSES**

WHEREAS, the Typhoon Ulysses that occurred last November 11 - 12, 2020 has gravely affected Region II – Cagayan Valley Region particularly the City of Tuguegarao, Province of Cagayan;

WHEREAS, President Rodrigo Roa Duterte has declared the entire Luzon under a State of Calamity in the wake of three typhoons that battered the country's largest island;

WHEREAS, the Cagayan Mega Flood caused by Typhoon Ulysses affected many residents in the area and now in dire need of any form of assistance from those who might be minded to intervene and respond, so as to soften the impact of the calamity which disrupted the livelihood and destroyed the properties of the residents thereat;


WHEREAS, the Members of the Sangguniang Bayan have agreed to provide an immediate assistance in those affected cities through monetary donation in the amount of Fifty Thousand Pesos (Php 50,000.00);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO DONATE ON BEHALF OF THIS MUNICIPALITY THE AMOUNT OF FIFTY THOUSAND PESOS (PHP 50,000.00) TO THE CITY GOVERNMENT OF TUGUEGARAO, PROVINCE OF CAGAYAN, FOR THE VICTIMS OF TYPHOON ULYSSES.
