A RESOLUTION GRANTING THE APPLICATION OF 7 ROSE PETALS DEVELOPMENT CORP., FOR A DEVELOPMENT PERMIT FOR A PROPERTY LOCATED AT KAYTIKLING, BRGY. DOLORES, TAYTAY, RIZAL

WHEREAS, the acquired properties of 7 Rose Petals Development Corp. were classified as commercial land located at Kaytikling, Brgy. Dolores, Taytay, Rizal;

WHEREAS, proposed development project is covered by TCT NO. 068-2020001916 with Tax Declaration No. 18-TY-002-14962 containing an area of 16,359 sq. mtrs.;

WHEREAS, the applicant had already submitted the pertinent documents and other requirements attesting that all were in conformity with the standards promulgated by law;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS THE APPLICATION OF 7 ROSE PETALS DEVELOPMENT CORP., FOR A DEVELOPMENT PERMIT FOR A PROPERTY LOCATED AT KAYTIKLING, BRGY. DOLORES, TAYTAY, RIZAL and should undertake the following:

1. Build a detention pond or reservoir connected from their drainage system or water ways to suppress and prevent floods in some areas of the Municipality;

2. Make a rip-rapping of all legal easement in their drainage water system as well as to maintain all existing water ways.

RESOLVED FURTHER, that the pertinent provisions of the existing Barangay and Municipal Ordinances and Resolutions, and all National Laws on the matter shall be strictly followed.

RESOLVED FURTHERMORE, that the Municipal Planning and Development Office shall monitor the Development of the said Commercial project up to its completion and the Development Permit be subject for cancellation or revocation if the applicant voluntarily failed to comply or violate any of the conditions indicated above or committed a willful misrepresentation.

RESOLVED FURTHERMOST, that the copy of this Resolution be furnished to all concerned for their information and appropriate action.
