WHEREAS, the Municipal Government of Taytay owns a property located at Sakbit Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal;

WHEREAS, a market building was constructed in the said property to help decongest the Municipal Public Market and bring the market closer to the residents of Lupang Arenda;

WHEREAS, the market building was privately owned and has been sold and transferred to its new owner Mr. Melquiades A. Robles, Proprietor of Juliana Wet and Dry Market;

WHEREAS, Mr. Melquiades A. Robles sent a letter of intent to the Municipal Mayor for the lease of property to revive and operate the market located at Sakbit Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. MAYOR GEORGE RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MR. MELQUIADES A. ROBLES, PROPRIETOR OF JULIANA WET AND DRY MARKET FOR THE LEASE OF PROPERTY LOCATED AT SAKBIT LUPANG ARENDA, BRGY. STA. ANA, TAYTAY, RIZAL.
