A RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF REPHIL GAS STATION ALONG RIZAL AVENUE BRGY. SAN JUAN OF THIS MUNICIPALITY TO ALLOW MOTORISTS TO USE THE PORTION OF THEIR STATION AS ACCESS ROAD FOR RIGHT TURNING VEHICLES FROM KAPALARAN GOING TO TAYTAY BAYAN AREA FOR THE HOLIDAY SEASON AND REITERATING THE PROHIBITION OF SIDEWALK VENDORS WITHIN THE VICINITY

WHEREAS, the Holiday Season has brought about continuous increase in the volume of vehicles plying the primary and secondary roads within Taytay day in and day out;

WHEREAS, the T-intersection at Kapalaran Street corner Rizal Avenue has served as an alternate road for motorists from Manila East Road going to Rizal Avenue/Bayan and Club Manila East/Market Road and the high volume of passers-by result in a gridlock in the area;





WHEREAS, allowing the corner portion of Rephil Gas Station to be used by right turning vehicles from Kapalaran Street during the holiday season can help ease the traffic congestion in the area and avoid blockages thus improving the traffic flow in the vicinity;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby RESPECTFULLY REQUESTS THE MANAGEMENT OF REPHIL GAS STATION ALONG RIZAL AVENUE BRGY.
