RESOLUTION NO. 258 series of 2020

A RESOLUTION GRANTING EXTENSION FOR THE PAYMENT OF REGISTRATION FOR THE RENEWAL OF BUSINESS PERMIT AND LICENSES UP TO MARCH 31, 2021 WITHOUT PENALTIES AND SURCHARGES

WHEREAS, payment of Business Permit and Licenses is one of the requirements being imposed on the Professional Tax Receipt that no Business Permit shall be issued without registration from the Department of Trade and Industry;

WHEREAS, President Rodrigo Roa Duterte by virtue of Proclamation No. 1021 extends the declaration of the State of Calamity throughout the Philippines from September 13, 2020 to September 21, 2021 due to COVID-19 Pandemic;

WHEREAS, due to increasing number of the business establishment in our Municipality, it is deemed necessary for the taxpayers to be given ample time for the settlement of their business permit and licenses to avoid unnecessary charges and penalties, as well as follow social distancing and the minimum health protocols during pandemic;

WHEREAS, it would be best to extend the payment of registration and renewal of Business Permit and License up to March 31, 2021 so as to follow the extension of working hours from 8:00 a.m. to 8:00 p.m. on the said day, relative to this as appropriate overtime pay for the personnel involved should be compensated accordingly;

WHEREAS, the Sangguniang Bayan had required all concerned departments and sections in the filing of Business Permit to provide a system of procedure in the implementation of the processing of payment for the convenience of the paying public;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS EXTENSION FOR THE PAYMENT OF REGISTRATION FOR THE RENEWAL OF BUSINESS PERMIT AND LICENSES UP TO MARCH 31, 2021 WITHOUT PENALTIES AND SURCHARGES.

RESOLVED FURTHER, that copies of this Resolution be furnished to all offices concerned for their information and appropriate action.
