A RESOLUTION EARNESTLY REQUESTING DPWH SECRETARY MARK A. VILLAR THRU DPWH RIZAL 1ST DISTRICT OIC-DE FERDINAND T. MONAKIL TO EXPEDITE THE COMPLETION OF THE DORMANT ILLUMINATION PROJECT ALONG ORTIGAS AVENUE EXTENSION UP TO MANILA EAST ROAD OF THIS MUNICIPALITY

WHEREAS, Article 2 Section 5 of the 1987 Constitution of the Philippines states that "The maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people...";

WHEREAS, the Mission of the DPWH is "To provide and manage quality infrastructure facilities and services responsive to the needs of the Filipino people in the pursuit of national development objectives";

WHEREAS, the illumination of the said roads will fulfill both the aforementioned provision of the Constitution and that of the mission of the Department of Public Works and Highways;

WHEREAS, there are more than 350 erected unfinished lamp posts along Manila East Road from Kaytikling area up to the vicinity of Veterans Park, Taytay, Rizal that have been without Lamp Post Bulbs for more than five (5) years now;

WHEREAS, the incomplete lighting project leaves motorists plying on a tenebrous road and this major thoroughfare remains as an accident-prone area because it is not well lighted despite being a National Highway that connects Metro Manila to Rizal and Laguna;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY REQUESTS DPWH SECRETARY MARK A. VILLAR THRU DPWH RIZAL 1ST DISTRICT OIC-DE FERDINAND T. MONAKIL TO EXPEDITE THE COMPLETION OF THE DORMANT ILLUMINATION PROJECT ALONG ORTIGAS AVENUE EXTENSION UP TO MANILA EAST ROAD OF THIS MUNICIPALITY.

RESOLVED FURTHER, that a status update on the said illumination project be furnished to the Sangguniang Bayan of Taytay by the DPWH Rizal 1st District Engineering Office for their perusal and reporting to their constituents.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to the concerned offices for their information and favorable appropriate action.
