**RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF
RIZAL GAMING CORPORATION FOR THE ESTABLISHMENT OF
PHILIPPINE OF AMUSEMENT AND GAMING CORPORATION ELECTRONIC
GAMING OUTLET AT ITSP COMMERCIAL BUILDING, KM. 6, ORTIGAS
EXTENSION, BARANGAY SAN ISIDRO, MUNICIPALITY OF TAYTAY,
PROVINCE OF RIZAL**

WHEREAS, this August body received a letter from MS. Marlyn Villanueva, Compliance Officer of Rizal Gaming Corporation, requesting for a resolution interposing no objection to the establishment of a Philippine Amusement of Gaming Corporation (PAGCOR) Electronic Bingo Outlet at ITSP Commercial Building, Km 6, Ortigas Extension, Barangay San Isidro, Taytay, Rizal;

WHEREAS, the Municipality of Taytay considers gambling generally unfavorable to the interest of the people. However, there are national laws, which allows the operation of certain games of chance and which the Municipality of Taytay cannot prohibited, but such activities;

WHEREAS, a resolution of no objection from the Sangguniang Bayan is one of the requirements by PAGCOR to allow operation to allow operation of such gaming establishment;

WHEREAS, Rizal Gaming Corporation, has committed itself to comply strictly with the existing and applicable rules, resolution, ordinances and other regulation of Rizal Gaming Corporation for the establishment and operation of PAGCOR approved electronic gaming outlet in the Municipality of Taytay, Province of Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby INTERPOSES NO OBJECTION TO THE APPLICATION OF RIZAL GAMING CORPORATION FOR THE ESTABLISHMENT OF PHILIPPINE OF AMUSEMENT AND GAMING CORPORATION ELECTRONIC GAMING OUTLET AT ITSP COMMERCIAL BUILDING, KM. 6, ORTIGAS EXTENSION, BARANGAY SAN ISIDRO, MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.



RESOLVED FURTHERMORE, any violation committed by the Rizal Gaming Corporation shall be subject for the revocation of permit to operate.


RESOLVED FURTHERMOST, the permit to operate shall be renewable every three (3) years to the Sangguniang Bayan.
