**RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF
TOPNOTCH BINGO TREND, INC. FOR THE ESTABLISHMENT AND
OPERATION OF PHILIPPINE AMUSEMENT AND GAMING CORPORATION
(PAGCOR)-APPROVED BINGO PARLOR (TRADITIONAL AND
ELECTRONIC BINGO BOUTIQUE) AT SM CITY TAYTAY, MANILA EAST
ROAD, BARANGAY DOLORES, IN THE MUNICIPALITY OF TAYTAY,
PROVINCE OF RIZAL**

WHEREAS, this August Body received a letter from Ms. Kristine Margaret Delos Reyes, requesting for a resolution interposing no objection to the establishment of a Philippine Amusement and Gaming Corporation (PAGCOR)-Approved Bingo Parlor (Traditional and Electronic Bingo Boutique) at SM City Taytay, Manila East Road, Barangay Dolores, Taytay, Rizal;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 Section 447 subsection 4 paragraph 7 provides for the authority of the Sangguniang Bayan to regulate the establishment, operation, and maintenance of entertainment or amusement facilities;

WHEREAS, the Municipality of Taytay considers gambling generally unfavorable to the interest of the people. However, there are national laws, which allows the operation of certain games of chance and which the Municipality of Taytay cannot prohibited, but such activities even if considered legal are subject to the regulatory powers of the local government unit concerned;

WHEREAS, PAGCOR Gaming Site Regulatory Manual for Bingo Games requires the submission of a council resolution or ordinance from the Local Government Unit stating no objection to the establishment and operation of a gaming site situated within its locality;

WHEREAS, a resolution of no objection from the Sangguniang Bayan of Taytay is one of the requirements by PAGCOR to allow operation of such gaming establishment in the municipality;

WHEREAS, Topnotch Bingo Trend, Inc., has committed itself to comply strictly with the existing and applicable rules, resolution, ordinances and other regulation of the Municipality of Taytay for the establishment and operation of PAGCOR-approved Bingo Parlor (traditional and electronic Bingo Boutique) in the Municipality of Taytay, Province of Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby INTERPOSES NO OBJECTION TO THE APPLICATION OF TOPNOTCH BINGO TREND, INC. FOR THE ESTABLISHMENT AND OPERATION OF PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)-APPROVED BINGO PARLOR (TRADITIONAL AND ELECTRONIC BINGO BOUTIQUE) AT SM CITY TAYTAY, MANILA EAST ROAD, BARANGAY DOLORES, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.


