## RESOLUTION NO. 282 series of 2021

A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT APPROXIMATELY TWENTY MILLION PESOS (PHP 20,000,000) FOR THE PURCHASE OF TWELVE (12) UNITS OF FULLY EQUIPPED AMBULANCES FOR THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, with the continuous growth of the more than 400,000 population and different industries in the Municipality of Taytay, the current inventory of Ambulances is insufficient to cater to the needs of our constituents in terms of transportation of patients to hospitals or health care facilities within the approximately 40 square kilometer area of the municipality and to other hospitals outside Taytay, Rizal;

WHEREAS, currently, the Municipality has only Five (5) Barangays which are relatively large compared to common barangay areas and populations, the smallest of which have approximately 30,000 residents and the largest having about 120,000 inhabitants thus leaving the current line-up of service vehicles inadequate to serve the needs of every sitios, puroks and subdivisions when emergencies arise;

WHEREAS, in preparation for the construction of the Rizal Provincial Hospital – Taytay Annex courtesy of the Provincial Government, having additional Ambulances assigned to each of the 5 Barangays and to the Municipal LGU will greatly augment the indispensable need for such vehicles that can cater not just residents of Taytay but also for the would-be patients from nearby municipalities;

WHEREAS, much to the desire of Local Government Unit of Taytay to purchase such service vehicles for each of the 5 Barangays and for the Municipal Government, it is deterred by the insufficient funds of this LGU, hence the prayer for help and assistance from the National Government for the realization of this pressing need;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY AND RESPECTFULLY REQUESTS HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT APPROXIMATELY TWENTY MILLION PESOS (PHP 20,000,000) FOR THE PURCHASE OF TWELVE (12) UNITS OF FULLY EQUIPPED AMBULANCES FOR THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned offices for their information, perusal and consideration.
