**A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING
HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT
OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS OF UP TO
APPROXIMATELY TWENTY MILLION PESOS (PHP 20,000,000) FOR THE
PURCHASE AND INSTALLATION OF CEILING FANS TO THE 892
CLASSROOMS FOR ALL PUBLIC ELEMENTARY, JUNIOR AND SENIOR
HIGH SCHOOLS, COLLEGE AND LSEN CLASSROOMS AND
AIRCONDITIONING UNITS FOR THE COMMON OFFICES OF EVERY
PUBLIC SCHOOLS WITHIN THIS MUNICIPALITY**

WHEREAS, Section 1 of Article XIV of the Philippine Constitution declares that "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, Classrooms in public schools in the Philippines when constructed usually do not include the installation of electric fans or in other cases have deficient units that do not cater to the needs of the number of students per class/section and the offices where the school's administration are stationed ought to be airconditioned to provide conducive work environment for our educators;

WHEREAS, having a suitable classroom with well-ventilated environment aims to motivate the teachers and boost the students' morale in learning as improving classroom conditions and addressing the needs of the school's resources, is a big factor in improving the quality of education;

WHEREAS, this current pandemic where face to face classes is postponed can be the appropriate time to install such necessity as no classes nor school activities will be interfered; likewise, in the case that the schools will be used as vaccination centers, having such appliances makes it much more essential;


WHEREAS, much to the desire of Local Government Unit of Taytay to purchase such equipment for all the classrooms and offices in every school, it is deterred by the insufficient funds of this LGU, hence the prayer for help and assistance from the National Government for the realization of this pressing need;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY AND RESPECTFULLY REQUESTS HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS OF UP TO APPROXIMATELY TWENTY MILLION PESOS (PHP 20,000,000) FOR THE PURCHASE AND INSTALLATION OF CEILING FANS TO THE 892 CLASSROOMS FOR ALL PUBLIC ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS, COLLEGE AND LSEN CLASSROOMS AND AIRCONDITIONING UNITS FOR THE COMMON OFFICES OF EVERY PUBLIC SCHOOLS WITHIN THIS MUNICIPALITY.
