**A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING
HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT
OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS
AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000) FOR THE
IMPROVEMENT AND URBAN GREENING OF KALAYAAN PARK IN THE
MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, Section 16 of the 1987 Constitution of the Philippines declares that "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature";

WHEREAS, parks and playgrounds significantly improve the physical and mental health of a community's citizens of all ages, making them a cornerstone for improved quality of life of children to senior citizens who regularly visits the Kalayaan Park;

WHEREAS, the Kalayaan Park was created for the people of Taytay for recreation, relaxation and promotion of good mental health and physical wellbeing and the venue has been witness to numerous events, programs, festivities and history of the Municipality;

WHEREAS, the park is in need of improvement and repairs to cope up with the changing needs of its patrons and to further encourage urban greening of the said park as numerous studies have shown that valuable green spaces help reduce stress and increase happiness as even a short stay in a park enhances one's sense of wellness, lowers stress and strengthens the immune system;


WHEREAS, much to the desire of Local Government Unit of Taytay to refurbish the Kalayaan Park, it is deterred by the insufficient funds of this LGU, hence the prayer for help and assistance from the National Government for the realization of this pressing need;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY AND RESPECTFULLY REQUESTS HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000) FOR THE IMPROVEMENT AND URBAN GREENING OF KALAYAAN PARK IN THE MUNICIPALITY OF TAYTAY, RIZAL.
