A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH LANDBANK OF THE PHILIPPINES (LBP) FOR THE RELEASE OF SALARIES OF JOB ORDER

BASED EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL UNDER THE LANDBANK MASTERCARD PREPAID CARD

WHEREAS, Section 16 of RA 7160 otherwise known as the Local Government Code of 1991 provides in part that every Local Government Unit shall exercise the powers necessary for its efficient and effective governance;

WHEREAS, the Municipal Government of Taytay, Rizal is still using the traditional way of payroll system for the release of salaries of its Job Order based employees;

WHEREAS, Landbank of the Philippines (LBP) have offered the Municipal Government of Taytay, Rizal its Electronic Payment Instrument - Landbank Mastercard Prepaid Card to be used for the salaries of the Municipality's Job Order based Employees;

WHEREAS, the Sangguniang Bayan requests the Landbank of the Philippines to present its services offered pertaining to the Landbank Mastercard Prepaid Card before its full implementation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH LANDBANK OF THE PHILIPPINES (LBP) FOR THE RELEASE OF SALARIES OF JOB ORDER BASED EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL UNDER THE LANDBANK MASTERCARD PREPAID CARD.

RESOLVED FURTHER, that the duly signed MOA shall be ratified first by the Sangguniang Bayan before its full implementation.
