A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE OR ENTER INTO A MEMORANDUM OF AGREEMENT WITH ANY PERSON OR ENTITY FOR THE PURCHASE OF PROPERTY TO BE USED AS RIGHT OF WAY FOR THE RESIDENTS OF SITIO TAGUMPAY, BARANGAY SAN ISIDRO, TAYTAY, RIZAL

WHEREAS, Sitio Tagumpay is one of the populous areas located at Barangay San Isidro and along the boundary lines of the Municipality of Taytay and Cainta both in the Province of Rizal;

WHEREAS, residents of the area had sought the help and assistance of the Municipal Mayor Hon. George Ricardo R. Gacula II on the solution regarding the possible closure of their right of way to the main road;

WHEREAS, the 11th Sangguniang Bayan finds the situation worth legislating so as to address the pressing needs of the residents in the area and to prevent escalating problems in the community in cases during emergency situations;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE OR ENTER INTO A MEMORANDUM OF AGREEMENT WITH ANY PERSON OR ENTITY FOR THE PURCHASE OF PROPERTY TO BE USED AS RIGHT OF WAY FOR THE RESIDENTS OF SITIO TAGUMPAY, BARANGAY SAN ISIDRO, TAYTAY, RIZAL.

RESOL VED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, to send copies of this Resolution to all concerned for their information and appropriate action.
