**A RESOLUTION EXTENDING THE PAYMENT OF REGISTRATION FOR THE
RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT PENALTIES
AND SURCHARGES FOR ONE (1) WEEK AFTER THE LIFTING OF THE
CURRENT ENHANCED COMMUNITY QUARANTINE IN TAYTAY, RIZAL AS
PART OF NCR+**

WHEREAS, President Duterte placed NCR+ which includes Taytay, Rizal under Enhanced Community Quarantine initially from March 29 to April 4 that may be extended depending on the situation;

WHEREAS, President Rodrigo Roa Duterte by virtue of Proclamation No. 1021 extends the declaration of the State of Calamity throughout the Philippines from September 13, 2020 to September 21, 2021 due to COVID-19 Pandemic;


WHEREAS, it is but fitting to adjust the dates of payments for business renewal without imposing penalties as a means of the Local Government Unit of Taytay in supporting our business sector during these trying times;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXTENDS THE PAYMENT OF REGISTRATION FOR THE RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT PENALTIES AND SURCHARGES FOR ONE (1) WEEK AFTER THE LIFTING OF THE CURRENT ENHANCED COMMUNITY QUARANTINE IN TAYTAY, RIZAL AS PART OF NCR+.

RESOLVED FURTHER, that copies of this Resolution be furnished to all offices concerned for their information and appropriate action.
