## **RESOLUTION NO. 300 series of 2021**

**A RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT OF THE  
2ND, 3RD AND 4TH QUARTER AS WELL AS SEMI-ANNUAL BUSINESS  
TAXES, FEES AND CHARGES UP TO JUNE 20, 2021 FOR THE 2ND  
QUARTER, SEPTEMBER 20, 2021 FOR THE 3RD QUARTER, NOVEMBER 20,  
2021 FOR THE 4TH QUARTER AND AUGUST 20, 2021 FOR SEMI-ANNUAL  
RESPECTIVELY WITHOUT PENALTIES, SURCHARGES AND INTERESTS**

WHEREAS, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, or charges without penalties, surcharges and interests but only for a period not exceeding six (6) months;

WHEREAS, President Rodrigo Roa Duterte by virtue of Proclamation No. 1021 extends the declaration of the State of Calamity throughout the Philippines from September 13, 2020 to September 21, 2021 due to COVID-19 Pandemic;

WHEREAS, Resolution No. 109-A Series of 2021 of the IATF placed the Municipality of Taytay under Modified Enhanced Community Quarantine (MECQ) until April 30, 2021 that may be extended depending on the situation;

WHEREAS, considering that the Municipality is continually under the state of Community Quarantine most business establishments are still in partial operation thus there is a need to extend the deadline for the payment of business taxes, fees and charges;

WHEREAS, it is but fitting to adjust the dates of payments for business renewal without imposing penalties as a means of the Local Government Unit of Taytay in supporting our business sector during these trying times;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXTENDS THE DEADLINE FOR THE PAYMENT OF THE 2ND, 3RD AND 4TH QUARTER AS WELL AS SEMI-ANNUAL BUSINESS TAXES, FEES AND CHARGES UP TO JUNE 20, 2021 FOR THE 2ND QUARTER, SEPTEMBER 20, 2021 FOR THE 3RD QUARTER, NOVEMBER 20, 2021 FOR THE 4TH QUARTER AND AUGUST 20, 2021 FOR SEMI-ANNUAL RESPECTIVELY WITHOUT PENALTIES, SURCHARGES AND INTERESTS.

RESOLVED FUTHER, that copies of this Resolution be furnished to all concerned Offices for their information and appropriate action.
