**A RESOLUTION HUMBLY REQUESTING MAYOR GEORGE RICARDO R.
GACULA II TO GRANT A HAZARD PAY CASH INCENTIVE TO ALL
MUNICIPAL EMPLOYEES WHO RENDERED THEIR SERVICES DURING
THE NCR PLUS FINANCIAL ASSISTANCE DISTRIBUTION**

WHEREAS, the State of National Health Emergency was declared by the President of the Republic of the Philippines, under Proclamation No. 922 due to the Pandemic brought about by COVID-19;

WHEREAS, DILG Officer-in-Charge Undersecretary Bernardo Florece Jr., Secretary Rolando Bautista and DND Secretary Delfin Lorenzana issued Joint Memorandum Circular No. 1, s 2021 dated March 31, 2021 to serve as guidelines in the distribution of the financial assistance to some affected individuals as approved by President Duterte;

WHEREAS, the Local Government Unit of Taytay formed several teams of validators, tellers and support personnel from the current municipal employees from different departments to facilitate the payout process in all venues of distribution for a couple of weeks;



RESOLVED FURTHERMOST, that the release of the incentive shall be effective as soon as the funds is available for the purpose.


RESOLVED FINALLY, that a copy of this Resolution be furnished to all concerned Offices of the Municipal Government of Taytay, Rizal for their perusal.
