RESOLUTION NO. 306 series of 2021

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR GEORGE RICARDO R. GACULA II, IN BEHALF OF THE MUNICIPALITY OF TAYTAY TO ENTER INTO A MEMORANDUM OF AGREEMENT AND DATA SHARING AGREEMENT WITH ALL LOCAL GOVERNMENT UNITS THAT HAVE AND WILL HAVE A CONTACT TRACING SOFTWARE DEVELOPMENT AGREEMENT WITH APPCASE, INC. FOR THE INTERCONNECTEDNESS OF ITS CONTACT TRACING SYSTEM

WHEREAS, the Sangguniang Bayan of Taytay enacted Ordinance No. 705, Series of 2021 otherwise known as the "Taytay Trail Ordinance" that digitizes the contact tracing in Taytay, Rizal for the convenience and protection of Taytayefios, requiring individuals and establishments to register, secure and use QR Codes for tracing of those who have been in contact with a COVID-19 positive person;

WHEREAS, the Sangguniang Panlungsod of Valenzuela enacted Ordinance No. 783 Series of 2020 otherwise known as the "Valenzuela Tracing Application Ordinance" and have entered into a Contact Tracing Software Development Agreement with Appcase, Inc.;

WHEREAS, the City Mayor of Pasig City issued E.O. No. 53, Series of 2020 and the Sangguniang Panlungsod of Pasig enacted Ordinance No. 49 Series of 2020 otherwise known as "Pasig Pass Ordinance" likewise had an agreement with Appcase, Inc.;

WHEREAS, the Sangguniang Panglungsod of Mandaluyong enacted Ordinance No. 814. 5-2021, An Ordinance Instituting the "MandaTrack" as their City's contact tracing application under Appcase, Inc. as well;

WHEREAS, The Antipolo City government, through City Ordinance No. 968-2020, has mandated establishments and those entering such to use the "Antipolo Bantay COVID-19" QR Code also under Appcase, Inc.;

WHEREAS, the contact tracing system of this Municipality is limited to its territorial jurisdiction and do not transcend to other cities and municipalities, thus there is a need to connect the systems for more effective and efficient measure to contain the pandemic, hence, it is necessary to execute a Memorandum of Agreement and Data Sharing Agreement between the LGUs that have and will have the same type of digitized tracing application;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE, MAYOR GEORGE RICARDO R. GACULA II, IN BEHALF OF THE MUNICIPALITY OF TAYTAY TO ENTER INTO A MEMORANDUM OF AGREEMENT AND DATA SHARING AGREEMENT WITH ALL LOCAL GOVERNMENT UNITS THAT HAVE AND WILL HAVE A CONTACT TRACING SOFTWARE DEVELOPMENT AGREEMENT WITH APPCASE, INC. FOR THE INTERCONNECTEDNESS OF ITS CONTACT TRACING SYSTEM.


RESOLVED FURTHER, that the interconnectedness of its Contact Tracing Systems shall be for contact tracing purposes only, subject to execution of Data Sharing Agreement and in compliance with existing Laws, Ordinances and all other issuances.

RESOLVED FURTHERMORE, that all Memorandum of Agreements and Data Sharing Agreements in relation to this Resolution shall be ratified by the Sangguniang Bayan of Taytay before its full implementation.

RESOLVED FURTHERMOST, that copies of this Resolution be furnished to all concerned offices and departments for their perusal.
